| | <p>Norton Proposed Charter Amendment (By Petition)</p> <p>CITY OF NORTON PROPOSED AMENDMENT TO CHARTER</p> <p>The Charter of the City of Norton, Ohio shall be changed and amended as follows:</p> <p>SEWER AND WATER RATE ASSESSMENTS, CONNECTION FEES, AND RATE LIMITS</p> <p>No City of Norton resident or owner of property within the boundaries of the City of Norton shall be assessed a fee for construction of any sewer or water lines within the City limits.</p> <p>City of Norton residents or owners of property within the boundaries of the City of Norton who are currently paying assessments for water or sewer lines within the City limits, shall have future payments of their assessments paid by the City of Norton from the date this Charter Amendment is approved by the electors.</p> <p>No City of Norton resident or owner of property within the boundaries of the City of Norton shall be charged to tie into, connect to, or otherwise access sewer or water lines within the City of Norton.</p> <p>Within the boundaries of the City of Norton, no residential water bill or sewer bill shall exceed \$35 per month; except that these monthly billing limits may be increased by an amount not to exceed 2% per year by a majority vote of council in favor of such an increase.</p> <p>Shall the charter amendment proposed by petition be approved?</p> | <p>City of Norton (Wayne County)</p> |

INSTRUCTIONS TO VOTER FOR INDICATING YOUR CHOICES ON A FEDERAL WRITE-IN ABSENTEE BALLOT (FWAB):

To complete a Federal Write-In Absentee Ballot (FWAB), go to www.fvap.gov. You have the option of downloading a blank, hard copy FWAB to complete by hand, or proceeding through electronic completion of the FWAB using the website's FWAB Wizard.

The first page of the FWAB is a Voter Declaration/Affirmation you must complete in order for your ballot to count.

After completing the Voter Declaration/Affirmation, use the initial election notice issued on the 100th day before the election and the updated election notice issued on the 45th day before the election as a guide to:

- (1) write the name of each candidate or issue contest for which you are casting a vote and then
- (2) write the name of your choice of candidate or choice for or against an issue.

After you have completed the FWAB, **you must PRINT the ballot and MAIL it to your county board of elections at this address: 470 Grant Street, Akron, Ohio 44311.** A complete listing of all county board of elections mailing addresses and contact information is available at <http://www.sos.state.oh.us/SOS/elections/electionsofficials/boeDirectory.aspx#dir>.

Do not send your ballot via e-mail or fax; Ohio law prohibits electronic transmission of a voted ballot.
