Notice is hereby given that in pursuance of Resolution Nos. 13-24 and 13-26 of the Board of Education of the Coventry Local School District, adopted on January 31, 2013 and February 5, 2013 there will be submitted to the electors of said school district at the Special Election to be held in said school district at the regular places voting therein on Tuesday, May 7, 2013, the issuing of bond's for the benefit of said school district for the purpose of constructing, renovating, remodeling, rehabilitating, adding to, furnishing, equipping and otherwise improving school district buildings and facilities, preparing and improving their sites and acquiring real estate buildings, and facilities, and interest therein, for school district purposes, in the principle amount of \$28,308,500, to be repaid annually over a maximum period of 34 years, and an annual levy of property taxes to be made outside the ten-mill limitation, estimated by the county fiscal officer to average over the repayment period of the bond issue 4.9 mills for each one dollar of tax valuation, which amounts to 49 cents for each one hundred dollars of tax valuation, to pay the annual debt charges on the bonds and to pay debt charges on any notes issued in anticipation of the bonds.
