ISSUE #

- 1 **HUDSON CSD** – Proposed Tax Levy (Additional) at a rate not exceeding 5.9 mills for current expenses, for a continuing period of time, commencing in 2010, first due in calendar year 2011.
- 2 **NORDONIA HILLS CSD** – Proposed Tax Levy (Additional) at a rate not exceeding 6.5 mills for current expenses, for a continuing period of time, commencing in 2010, first due in calendar year 2011.
- 3 **STOW-MUNROE FALLS CSD** – Proposed Tax Levy (Renewal) at a rate to average 4.56 mills for emergency requirements of the district, for five years, commencing in 2011, first due in calendar year 2012.
- 4 **TWINSBURG CSD** – Proposed Tax Levy (Renewal) at a rate to average 5.03 mills for emergency requirements of the district, for ten years, commencing in 2011, first due in calendar year 2012.
- 5 **GREEN LSD** – Proposed Tax Levy (Additional) at a rate to average 6.71 mills for emergency requirements of the district, for five years, commencing in 2010, first due in calendar year 2011.
- 6 **MOGADORE LSD** – Proposed Tax Levy (Additional) at a rate not exceeding 8.49 mills for current expenses, for a continuing period of time, commencing in 2010, first due in calendar year 2011.
- 7 **REVERE LSD** – Proposed Tax Levy (Additional) to average 4.85 mills for emergency requirements of the district, for ten years, commencing in 2010, first due in calendar year 2011.
- 8 **SPRINGFIELD LSD** – Proposed Tax Levy (Renewal) at a rate not exceeding 1.8 mills for general permanent improvements, for five years, commencing in 2011, first due in calendar year 2012.
- 9 **SPRINGFIELD LSD** – Proposed Tax Levy (Renewal) at a rate to average 3.52 mills for emergency requirements of the district, for five years, commencing in 2011, first due in calendar year 2012.
- 10 **VALLEY FIRE DISTRICT** – Proposed Tax Levy (Renewal) at a rate not exceeding 2.5 mills for providing and maintaining fire apparatus and appliances, buildings and sites therefor, for five years, commencing in 2011, first due in calendar year 2012.

- 17 **CITY OF AKRON** – Proposed Charter Amendment – Shall Section 86e of the Charter be adopted to add a section to allow 1/3 of the 1/4% income to be used for public safety purposes in years 2011, 2012 and 2013 to extend collection of the 1/4% income tax from 2034-2038 for the Akron Community Learning Centers.

- 20 **AKRON 5-K** – Proposed Local Option - Shall the sale of wine and mixed beverages be permitted for sale on Sunday between the hours of eleven a.m. and midnight by Kimi One, Inc., dba Sunrise Convenience Food Mart in this precinct?
- 21 **AKRON 6-C** – Proposed Local Option - Shall the sale of spirituous liquor be permitted for sale on Sunday between the hours of ten a.m. and midnight by DST Miller d.b.a. papa don’s pub and grille in this precinct?

- 66 **PENINSULA VILLAGE** – Proposed Income Tax Increase – Increase the income tax from 1% to 2 %.
- 67 **PENINSULA VILLAGE** – Referendum on Ordinance #129-2009 (by petition). Proposing R1 Rural Residential District Acreage Designation be changed from 4 acres to 2 acres excepting

Brandywine Country Club and Golf Course real estate and the Western Reserve Girl Scout Camp real estate.

- 68 **PENINSULA VILLAGE** – Referendum on Ordinance #130-2009 (by petition). Changing R1 Rural Residential District Acreage Designation from 200-foot frontage to 150-foot frontage.
- 69 **PENINSULA VILLAGE** – Proposed Charter Question – Shall a Commission be chosen to frame a Charter?
- 70 **COVENTRY TOWNSHIP** – Proposed Tax Levy (Renewal) at a rate not exceeding 0.95 mills for current expenses, for five years, commencing in 2011, first due in calendar year 2012.
- 71 **NORTHFIELD CENTER TOWNSHIP** – Proposed Tax Levy (Renewal) at a rate not exceeding 1.4 mills for general construction, reconstruction, resurfacing, and repair of roads, for five years, commencing in 2010, first due in calendar year 2011.
- 72 **SAGAMORE TOWNSHIP** – Proposed Tax Levy (Renewal) at a rate not exceeding 0.75 mill for fire, for a continuing period of time, commencing in 2011, first due in calendar year 2012.
- 73 **SPRINGFIELD TOWNSHIP** – Proposed Tax Levy (Replacement and Increase) replacement of 1 mill and increase of 1 mill at a rate not exceeding 2 mills for Fire and EMS, for five years, commencing in 2011, first due in calendar year 2012.
- 74 **TWINSBURG TOWNSHIP** – Proposed Tax Levy (Replacement) at a rate not exceeding 3 mills for the purpose of police, for continuing period of time, commencing in 2010, first due in calendar year 2011.
